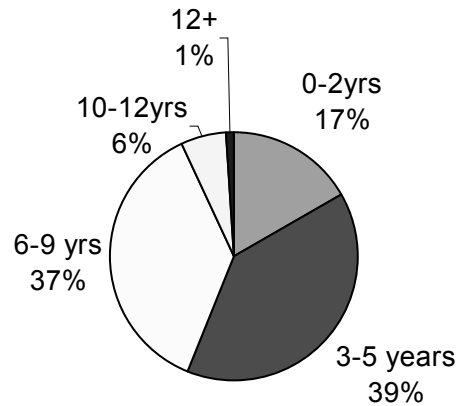

2009-10 FY Visitors by Age



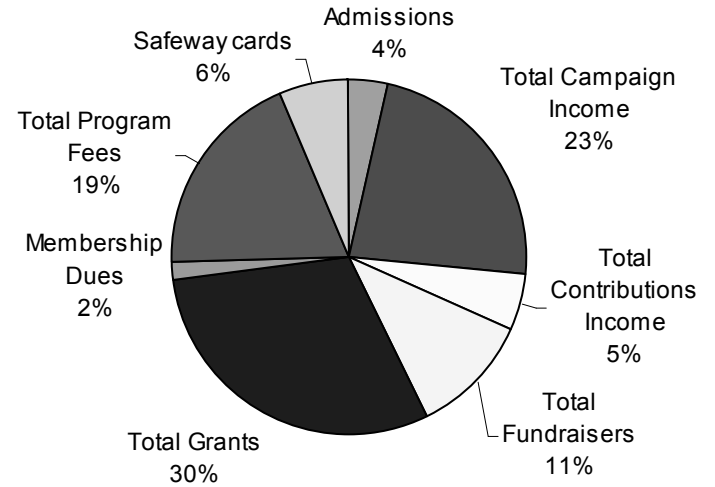

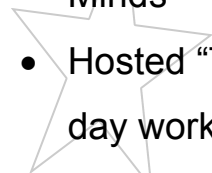
